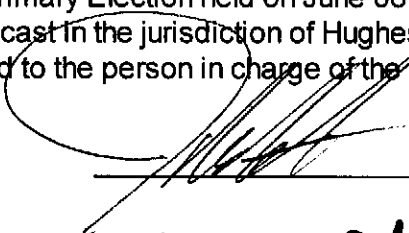


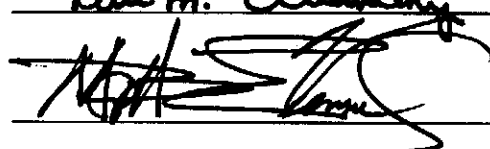

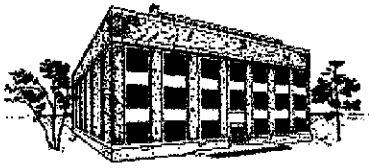

The Hughes County Commission has canvassed the original official returns for the June 8, 2010 Primary Election. They have determined that there was a tie vote for the Precinct #21 Committeeman and it is impossible to declare who has been elected to that position.

Therefore, as stated in SDCL 12-21-16, we are required to conduct a precinct recount to determine the winner of that race.

“The presiding judge shall appoint a (recount) board, pursuant to §12-21-2” and “The board shall convene in the office of the county auditor on the second Monday at nine a.m.” I believe that date would be June 21, 2010.
